Updated satellite imagery is also used to detect any easement violations.

Schedule D, Part II, Line 5 - Overflight by aircraft or purchase of satellite imagery is generally sufficient to determine whether violations have occurred because easements conserve remote undeveloped wilderness. Man caused development is relatively easy to detect. To date, no violations of easements have been observed. Actual physical on-site presence on most easements properties is problematic because there is no access.

The trust did not expend any funds to acquire these easements and they have no value because the landowner retains title to the land subject to the easements. Other conservation organizations purchased the easements and transferred title to them to the Land Trust for stewardship and monitoring, or the Land Trust received grants or donations specifically for purchasing the conservation easements.

Schedule D, Part V, Line 1f - The numbers reported for year-end balances are net of management fees. As such, to include the fees on line 1f would create an error in the reported year-end balances. Management fees in 2024 were \$7122.

Permitted uses include paying direct costs for monitoring the properties for violations of conservation easement terms, paying legal costs to defend the easements or prosecute violations of the easements, and paying costs for any liability insurance or insurance to protect against trespasses and easement violations.
